

The Commissioned Corps will open the application process on December 11 and 12, 2014 at 9:00AM EST for qualified Physician Assistant candidates willing to serve in the Bureau of Prisons, and/or the Indian Health Service.

For this application process candidates will only be accepted for the positions identified below. Candidates who fail to apply for or secure an assignment with one of these agencies are subject to closure. The Corps will screen and accept the first 30 qualified candidates. Once the maximum number of qualified candidates is identified, the screening process will be closed for this cycle.

All candidates must possess a qualifying Bachelor's and/or Master's degree in Physician Assistant with a valid and unrestricted Physician Assistant license as of December 12, 2014. During the Commissioned Corps Recruitment Call Center screening process, each candidate must identify three preferred locations from the list below and affirm their commitment to secure an assignment within these agencies.
