LOCATION DESCRIPTION

Camp Lejeune is the home for the II Marine Expeditionary Force, 2nd Marine Division, 2nd Marine Logistics Group and other combat units and support commands.

The base and surrounding community is home to an active duty, dependent, retiree and civilian employee population of approximately 170,000 people. The base generates almost \$3 billion in commerce each year, coming from payrolls and contracts to support the structure required to train and equip our modern Marines.

Some services available aboard Camp Lejeune include: childcare, shopping, education, family support, hunting and fishing, dining, boating and swimming.

Some facilities on base include banks and credit unions, the commissary, the library, hobby shops, fitness centers, the beach, theaters and more.

Specific duties and responsibilities include, but are not limited to the following:

SLP for Naval Hospital Camp Lejeune, for a three year minimum tour.

The Incumbent will identify and treat communication and/or language problems as a result of a TBI. S/he will identify and treat cognitive problems using evidenced-based treatment to improve TBI care. Provides direct patient care to improve communication skills through vocal exercises and cognitive therapies. S/he is an active participant in the multidisciplinary TBI team. S/he will use written and oral tests, as well as special instruments, in the diagnosis and treatment of language related issues. S/he establishes individualized care plans tailored to each patient's needs. Services will be provided at Naval Hospital Camp Lejeune to include the branch clinics, as required. Will also assist as needed to support other NHCL beneficiaries who require care by a Speech and Language pathologist to optimize treatment outcomes.
